## NOTA SU SVIZZERA

Dal 26 maggio 2021 il Consiglio federale ha messo in vigore il nuovo diritto svizzero sui dispositivi medici. Per garantire lo stesso livello di qualità, sicurezza ed efficacia previsto negli Stati membri dell'UE, la revisione si è basata sul nuovo regolamento UE relativo ai dispositivi medici (MDR1).

L'implementazione del regolamento europeo relativo ai dispositivi medico-diagnostici in vitro (IVDR2) in Svizzera è prevista per il 26 maggio 2022. Con la normativa precedente (direttive 90/385/CEE, 93/42/CEE/ e 98/79/CE), l'**Accordo di reciproco riconoscimento (anche MRA, Mutual Recognition Agreement) tra la Svizzera e l'UE dava alla Svizzera** l'accesso al mercato unico europeo dei dispositivi medici come partner paritario, dandole la possibilità di condurre un'attività di sorveglianza efficace ed efficiente del mercato dei dispositivi medici in collaborazione con le autorità competenti degli Stati membri dell'UE. Grazie a questo accordo è stato possibile evitare barriere tecniche al commercio tra le due parti. I pazienti svizzeri hanno inoltre potuto beneficiare dell'intera gamma europea di dispositivi medici. Con l'entrata in vigore della nuova normativa svizzera sui dispositivi medici avrebbe dovuto essere aggiornato anche l'MRA. Tuttavia, la **Commissione UE non ha perseguito l'aggiornamento di questo accordo** necessario a partire dal 26 maggio 2021 a causa del contesto politico di fondo (interruzione dei negoziati dell'accordo quadro istituzionale tra la Svizzera e l'UE).

A causa del **mancato aggiornamento dell'MRA**, la Svizzera ha definito delle misure volte ad attenuare gli effetti negativi di questo sviluppo, in particolare l'accesso alla banca dati europea centrale dei dispositivi medici (EUDAMED 3) non concesso all'autorità svizzera e la mancanza di collaborazione nella sorveglianza del mercato. In queste misure rientrano p.es. i termini scaglionati per la designazione di un **mandatario («CH-REP»)**, l'obbligo di registrazione degli operatori economici presso Swissmedic, la notifica di incidenti gravi a Swissmedic e il riconoscimento dei certificati di conformità dell'UE in Svizzera.
